



Board of Education Meeting Highlights November 27, 2017

- Chair Sharon Warden called the meeting to order.
- RRMS student, Emma Montero, led the Pledge of Allegiance. Dr. Larry W. Cartner, Superintendent, requested a moment of silence.
- The Board approved the agenda for November 27, 2017.
- Sharon Warden recognized the guests in attendance.
- Superintendent Cartner shared information on the following:

 - *TOY Report for Board* – Dr. Cartner welcomed Tia Carver, 2017-2018 Teacher of the Year for RRMS, to share with the Board some thoughts on serving as Teacher of the Year for his school. ECPPS has Teacher of the Year representatives attend the monthly meetings to provide information for the Board.
 - United Way Recognition of District Campaign – Bill Blake, Executive Director with Albemarle Area United Way, thanked the district for ECPPS campaign this year which totaled \$12,362. He also recognized four schools that met 80% or more in staff participation. The four schools included: ECP Early College, H.L. Trigg Community School, P.W. Moore Elementary School, Sheep-Harney Elementary School
