MINUTES BOARD OF EDUCATION ELIZABETH CITY-PASQUOTANK PUBLIC SCHOOLS January 19, 2016

The Elizabeth City-Pasquotank Board of Education met on Tuesday, January 19, 2016, 3:10 p.m., for the purpose of holding Committee Meetings. The meetings were held in the Board Room of the Administration Building.

I. Academic Affairs Committee

Dr. Cartner informed members that Board Attorney, John Leidy, would attend the meeting and under "other" discuss a lawsuit being filed against the state by some school systems.

Members discussed Policy 7340 – Employee Dress and Appearance. It was decided to remove the section regarding flip-flops and to make the policy effective July 1, 2016.

Members discussed Policy Series 7000, Section B. The policies have been under review and it was recommended that they be placed on the January 25, 2016, consent agenda for approval.

Mr. Overman informed members that the current policy regarding committee structure would need to be changed and aligned with the new committees that would be formed based on the system goals. This will be placed on the February Policy Committee Agenda.

John Leidy discussed a lawsuit being filed by several school systems against the state in order to recover monies that were paid to the state as fines for "improper equipment" on vehicles and were not paid to school systems through fines and forfeitures as mandated by General Statute. Mr. Leidy recommended that the Board request permission to be added to the pending lawsuit and asked for direction on how to proceed.

Board members discussed the matter.

A motion was made by Pam Pureza, seconded by Harvey Beasley, and unanimously carried to proceed with the recommendation to request permission to join the lawsuit.
