Christie Pauley presented an update on AVID. She shared the Mission & Vision statement of AVID and ECPPS and how they both align as a district. Ms. Pauley shared AVID's Platform which is writing, inquiry, collaboration, organization and reading. She stated last year the district added two elementary schools and student increase in middle schools by 30 percent. Ms. Pauley also shared the positive impact AVID has on students, parents, quality education, community, and available workshop opportunities.

Amber Godfrey shared an update on Battle of the Books. She said 73 students participated from our elementary schools. Ms. Godfrey shared an updated flyer on upcoming Battle of the Books events.

Rhonda James-Davis presented a proposed project to build a training fire tower for the fire and carpentry students at Pasquotank County High School. Ms. James-Davis introduced Mr. Dwayne Crank, Mr. Eugene Rountree, and Deputy Chief Chris Carver. Mr. Crank stated the fire tower would be built behind the school and both classes would have excess to the fire tower. The instructors said the building would be 36 ft. by 38 ft. to include door space to house the fire truck used for the firefighting program and also a training area. Ms. James-Davis said the cost would be about \$15,000.00 to purchase some of the materials.

Ms. Amber Godfrey shared an introduction on the Mursion Simulation process that provides our educators a space to practice what they have learned in the classroom with an opportunity to get feedback from virtual students, peers and professors.
