I. Financial, Business and Technology Systems Committee

Mr. Cox presented information on the following:

- Energy Discussion

In June, multiple energy efficiency companies shared their proposals during a Committee Meeting. A quick synopsis was provided by Mr. Cox on what each company offered.

Members discussed the energy and saving needs of the district. They also discussed the cost of last year's utilities and the current budget set for 2018-19 utility costs. Representatives from Schneider Electric and Cenergistic spoke briefly on what their companies focus on. Mr. Cox shared that he will conduct more research and come back with a recommendation for one of the four energy efficient companies that provided ECPPS with a proposal.

Dr. Joanne Sanders shared information on Next Steps with K2 1:1. They would like to use the money on IPads, not on Chromebooks. IPads are easier for the students to use. No additional money is needed to acquire the iPads.

Members indicated that Next Steps with K2 1:1 should go on the August 27, 2018 consent agenda for approval.

Frankie Floyd shared information in regards to School Safety & Cameras. He shared that the two middle schools, ECMS and River Road, are completed. By the end of the week, the hope is to have the servers installed in all the elementary schools and are working on H.L. Trigg Community School.

No action was taken at this time for School Safety & Cameras.

Ms. Sharon Warden shared information on the NCSBA District 1 Meeting. The District 1 Meeting will be held in the Bertie County School District at Bertie County High School on September 5, 2018 from 4:00pm to 8:00pm. Members discussed departure time and travel arrangements for this meeting.

Rhonda James-Davis spoke on the Demonstration Farm Update. She shared the difficulty in reaching the landowner of the farm. The next step is for the landowner to sign the lease agreement and is still waiting for that to happen. There may be some changes to the agreement but that must go through the Board for approval. Ms. James-Davis still has not heard back from the landowner and is unsure of why he has been unresponsive.

Jennifer Hawkins reported on the Alternative Accountability Model Options. She reported that each year H.L. Trigg Community School has a choice to do the Alternative Accountability Model like every other school in North Carolina, they can choose an alternative progress model, or create their own plan. The District usually uses the 20 percent performance, 20 percent persistence, and 60 percent progress model.

ECPPS would like to choose Option B, the Progress Model if we have enough kids in each subgroup. Should there not be enough scores in regards to the Every Student Succeeds Act (ESSA), then you have to have another plan. We could go back 3 years and hope to have 30 students in each subgroup and make a letter grade out of that, or

return the scores back to the home schools and take letter grades from those schools. We would like to use the letter grade from the home schools if this were to happen.

Members indicated that the Alternative Accountability Model can be placed on the consent agenda for the Regular Meeting on August 27, 2018.
