Dr. Cartner and Board Members discussed Reform Model Options available for Low Performing Schools (Transformation Model, Restart Model, Turnaround Model and School Closure) to keep them out of the pool of potential schools to be part of the State's Achievement School District. There was lengthy dialogue about the options available and the need to make decisions in the best interest of children.

A motion was made by Dr. Denauvo Robinson, and seconded by Walter Jolly, to place P. W. Moore Elementary School and Elizabeth City Middle School in Transformation Model taking them out of the State's Achievement School District pool and to accept the recommendation of the superintendent to place Pasquotank Elementary School and River Road Middle School in Restart Model taking them out of the State's Achievement School District pool. Voting for the motion were Walter Jolly, Dr. Denauvo Robinson, Barry Overman and Virginia Houston. Voting against the motion were Pam Pureza and Dr. Sheila Williams. The motion carried.
