| Michael<br>Thompson | Going Orange<br>"No Kid Hungry" | <ul> <li>Thompson discussed the "Going Orange – No Kid Hungry" Program. He shared facts about students that are at risk of hunger and about the benefits of eating breakfast. He indicated his goal is to increase the number of students eating breakfast. He reported that he is beginning the program in one elementary school this month.</li> <li>Thompson shared options that could be used in schools regarding providing breakfast for all students (i.e. Breakfast in the Classroom, Grab &amp; Go, and 2nd Chance).</li> <li>Thompson asked principals to consider trying one of the alternative means of serving breakfast.</li> <li>There was group discussion regarding the options, the associated costs, menu items, eating in classrooms, etc.</li> <li>Questions were asked about "who pays" and Thompson shared that some schools may qualify for "universal free" breakfast and for those that do not students will have to pay for breakfast. He suggested that the community could be asked for assistance.</li> <li>Thompson informed the Team that he is investigating moving toward CEP (Community Eligibility Provision) for next year. This would mean that schools with a certain % of identified low-income students would qualify for "no cost" meals.</li> </ul> |

| Webinar | Monitoring the<br>Digital Playground | Dr. Cartner discussed the need to change the system policy on access to the internet. Changes are underway that will require individuals to long on for access which will provide increased security as it relates to social media issues. He discussed social media programs and indicated some cannot be blocked.<br>Team members viewed the streamlined presentation hosted by NCSBA on "Monitoring the Digital Playground." The presentation was from Social Sentinel and centered around school threat assessment. Opportunities for Q&A were provided during the presentation. | Larry Cartner | Book Study Check<br>Up        | Dr. Cartner reminded principals to make sure they are on track to complete<br>the book study. He stated that he appreciates the stories that have been<br>shared to date and is in the process of picking out books for next school year.<br>He discussed a couple of books he is considering (Teaching With Poverty in<br>Mind by Eric Jenson and Awakening the Learner by Darrell Scott & Robert<br>Marzano.                           |
|               | Strategic Planning<br>Process | Dr. Cartner reported that the Strategic Planning Task Force wrapped up<br>yesterday and the next step in the SP Process will be for district level staff to<br>put in specific outcomes. He expects this process to take 30-50 days. He<br>reported that there was a good mix of community leaders on the SPTF and<br>each school was represented in some way.   |
|               | TOY Candidates                | Dr. Cartner asked principals to think about individuals selected as Teacher of<br>the Year and to think about if the individual representing their school had met<br>growth. He clarified that he did not say a teacher that had not met growth<br>could not be TOY, but he encouraged principals to think about the message it<br>sends if they have not.   |
|               | 2016-17 Calendar              | Dr. Cartner distributed copies of the 2016-17 school year calendar, which was<br>approved by the Board on 2.29.16. He discussed calendar law parameters and<br>the fact that school could not start prior to 8.29.16 by law. He discussed early<br>release days and told principals they are for school-level professional<br>development – he indicated it might not be good to schedule PD on 9.2.16,<br>11.22.16, 12.21.16 or 6.9.17. |

| Larry Cartner | Last Word & Pass<br>The Bell | Dr. Cartner encouraged principals to think about school and bullying issues –<br>where do you draw the line between what is normal "kid" behavior and what<br>crosses the line. He encouraged principals to be able to answer and talk about<br>the difference with parents. He shared that "bullying" was a topic mentioned<br>frequently at the Community Forum meetings. He asked principals to think<br>about what is happening in their school and how they could address issues<br>when parents think it is bullying – it could be something as simple as have you<br>talked to the parent of the "alleged" bully.   |

|               |                              | Dr. Cartner discussed the upcoming Teacher Working Condition Survey.   |
|               |                              | Dr. Cartner shared a handout with comments from the Strategic Plan<br>Community Forum which had the comments listed under the goals they<br>referenced. He asked everyone to spend time looking at the comments and see<br>if they were things they recognized from their school. He encouraged them to<br>not be hurt/angered by the comments and to remember that the forums were<br>an "open mic" opportunity.  |
|               |                              | Dr. Cartner shared that he is a fan of Harry Potter movies and one is "The<br>Prisoner of Azkaban." He encouraged everyone to not let "us"/"yourself"<br>become a Prisoner of War. If you see every situation as "this" or "this", you<br>have limited your options and you become a prisoner of war. He encouraged<br>everyone to think about what you can do to approach things differently as<br>standards are being raised so that they do not become a POW – He discussed<br>that when leaders tell a group, "I have been told to" that it limits their<br>power. He reminded everyone that in the July meetings he had indicated<br>everyone should be able to "carry your own water." He asked principals to<br>think about how different things would be in their building if they removed<br>phrases like, "this is what I have been told" or "I have been told to" |

| <b>"Not Home Yet"</b><br>The story of an elderly, missionary couple that had been working in Africa for years and was returning to New York to retire.
